When Congress renewed the Magnuson-Stevens Fishery Conservation Act in 2007 the act contained this language:

“(1) FEDERAL PROGRAM – The Secretary shall establish and implement a regionally based registry program for recreational fishermen in each of the 8 fishery management regions. The program, which shall not require a fee before January 1, 2011, shall provide for-

(A) the registration (including identification and contact information) of individuals who engage in recreational fishing...

STATE PROGRAMS – The Secretary shall exempt from registration under the program recreational fishermen and charter fishing vessels licensed, permitted, or registered under the laws of a State if the Secretary determines that information from the State program is suitable for the Secretary’s use...”

Because many EJTU members restrict their fishing to fresh water streams and ponds, they don’t think much about the past years’ discussions about the salt-water registration that the Federal government requires. Moreover, since registration in 2010 was free, even if you fished for shad in the Delaware, or stripers in the Hackensack you might have felt that registering was only a minor inconvenience. It is a minor inconvenience no longer.

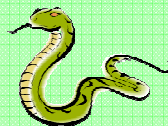
A Touch of Nature

New Jersey Fish and Game Council

New Jersey's Fish and Game Council oversees the Division of Fish and Wildlife, adopts the game code and has great influence on our outdoor activities.

The eleven Council members, all appointed by the Governor, represent a variety of interests: three are farmers, recommended to the Governor for appointment by the agricultural convention; six members are sportsmen, recommended to the Governor for appointment by the New Jersey State Federation of Sportsmen's Clubs; the Chairman of the Endangered and Nongame Species Advisory Committee; and a public member "knowledgeable in land use management and soil conservation practices". Northern, central and southern areas of the State are each represented by one of farmers and two of the sportsmen.

When deciding a case that concerned the makeup of the Council the NJ Supreme Court commented as follows:

"The Fish and Game Council is invested with certain regulatory powers aimed at protecting and developing an adequate supply of fish and game for recreational and commercial purposes. These powers are expressed primarily

when and where in the State hunting and fishing shall take place, and which freshwater fish, game birds, game animals, and fur bearing animals may be taken and in what numbers. The wildlife thus regulated is those animals which are the focus of the sports of hunting and fishing. In addition, the Council supervises a program of wildlife propagation, the expenses of which are supported by fees for hunting and fishing licenses paid for by sportsmen and commercial fishermen"

Therefore, the Council's essential and primary responsibility as noted by the Supreme Court is aimed at protecting and developing an adequate supply of fish and game for recreational and commercial purposes. This limited responsibility is implemented through adoption of the Fish Code and the Game Code and in the development of comprehensive policies for the consideration of the Commissioner of Environmental Protection, the Governor and the Legislature.

The acting Chair of the Council, Jeanette Vreeland, is completing her term on the Council and will be replaced on January 1, 2011. Beginning in January 2011 the Council will be chaired by Agust Gudmundsson, one of the most active of New Jersey's Trout Unlimited members.

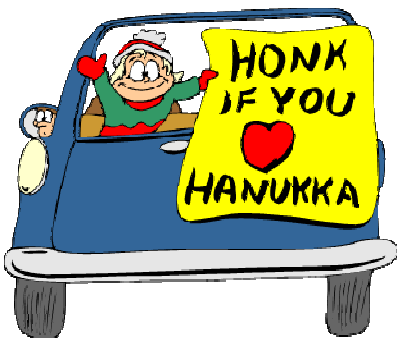

Since New Jersey authorities have done nothing toward instituting a New Jersey registration system – a step that would have ensured that license fees and other funds accrue to the State – NOAA has announced that beginning in January 2011, if you wish to fish in salt water or waters that hold anadromous fish, you will have to pay the Federal Government \$15. The new fee applies to “anglers, spear fishers and for-hire fishing vessels.”

If you are unsure of whether you must register, New Jersey fishermen must register if they:

- + Fish for or catch anadromous species in tidal and salt waters; these are fish like river herring, shad or striped bass that live in the oceans but spawn in fresh water, or
- + Fish in the Federal waters more than three miles from the ocean shore or from the mouths of rivers or bays, or Don't meet any of the exceptions in the law.
- Those exceptions include anglers who:
 - are under the age of 16.
 - have a currently valid saltwater license from another state whose license meets the criteria of the Angler Registry.
 - are already registered with NOAA in 2010 to fish saltwater in another state.
 - only fish on vessels that are holders of for-hire (or charter boat and party boat) permits issued by NOAA Fisheries.
 - hold a Highly Migratory Species Angling permit.
 - are fishing commercially under a valid license.

Keep in mind that it is the Federal Government that requires that saltwater fishermen be registered. If New Jersey does not have a license in place, there will be federal funds that New Jersey will not be eligible to receive. Also, apparently there are landlocked states that have saltwater licenses and, as a result, receive some funding.

Some groups have suggested that New Jersey have free registration.

This seems attractive until you consider that someone must administer the “free” program and the someone would probably be New Jersey’s Division of Fish and Wildlife.

If the Division were to be given this added responsibility, additional personnel and equipment would most likely be necessary and the personnel and hardware expenses would have to be paid for. Would New Jersey’s politicians be willing to add expense lines to the State’s budget, particularly in the midst of cost cutting moves, or would they expect the Hunters and Anglers Fund to pay for this added “angling” expense? If the Hunters and Anglers fund is tapped, it, it would mean that dollars that come from hunting and fresh water fishing licenses would allow salt water fishermen to fish at no cost to them.

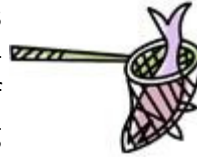
Meanwhile, Delaware has instituted an \$8.50 resident license that covers fishing, crabbing, and clamming. Will Federal funding be based on the number of registered salt water anglers? If so, will little Delaware be able to obtain more federal funds than New Jersey if it shows a registry with more anglers than New Jersey? If New Jersey does not institute a license, will the Federal government charge New Jersey for the cost of monitoring the catch reports? When licenses are issued by the government rather than New Jersey, will New Jersey wish that it was receiving the \$15 per New Jersey angler that instead will go to NOAA?

Freshwater Fisheries Forums

The NJDEP's Division of Fish and Wildlife will hold public forums to discuss freshwater fisheries culture, research, management and recreational angling in New Jersey at 10 AM on Saturday, December 4 at the Hacktstown State Fish Hatchery in Warren County.

Another forum will be held in South Jersey on February 26, 2011 at the Batsto Village Visitors Center in Wharton State Forest.

Anglers are invited to share their views and recommendations for the future of freshwater fisheries research and management in New Jersey with staff biologists. These forums are of particular importance as fisheries staff will soon be developing recommendations for regulations changes for the 2012 Fish Code.



There are two areas on the agenda on which biologists would like input. One is the types of waterbodies that anglers believe should be stocked as part of the Division's Winter Trout Stocking Program. Waterbody size, access type, ice fishing restrictions, etc., are areas open to discussion.



The other is to hear from the public which characteristics biologists should consider for a stream to have a Wild Trout Stream designation. This would include type of fishery, access, etc.

Anglers are invited to ask questions and comment on any aspect of the division's fisheries management programs. By providing input, the public can help guide the development of all New Jersey's freshwater programs and the regulations which govern them.

Pre-registration is not required but is appreciated, and will help ensure that all attendees can be accommodated.
